You may choose to pay by Credit card (Visa / MasterCard) **Regular Registration and Early Registration into the Courses: ONLINE:** Payment by credit card only.

MANUAL: Applications for courses are registered according to the order in which full payment of the tuition fee is received, since the number of participants per course is limited. The ESAVS reserves the right to decline a registration without further explanation.

Cancellation: In the event of a cancellation received less than 6 weeks (42 days) prior to the course starting, a no-show situation or a cancellation during the course, no refunds will be granted. The ESAVS reserves the right to retain 50% of the payment received, if the cancellation has been made at 6 weeks (42 days) prior to the course.
